Terms of Agreement

In order to create a competitive and equal SEQW premiership, the following agreement terms are outlined below:

1. Player Commitment:

The following outlines the player commitment required in order to effectively participate within the SEQW competition for 2021.

- **BHP Club** – Is required to split squad of thirty (30) into multiple affiliate clubs (e.g. If two affiliate clubs, split 15/15) via completion of *Appendix 1 Player Allocation*.
- **Permits** – The BHP Club will be responsible for permitting the allocated players to their affiliated SEQW team via MySideline.

2. Recruitment of Key Club Roles and Coaches:

It is encouraged that the BHP Premiership Club jointly recruit the roles (if agreed and required) as per the requirements of the SEQW Premiership:

- Head Coach
- Sports Trainer
- Leaguesafe Trainer

3. Governance Requirements:

- Reporting requirements on the partnership/agreement as per the QRL guidelines
- Regular reviews of competition and affiliation partnership will be monitored from time to time
- All clubs to review the QRL policies that currently support the SEQW Premiership
